Ozzie Neal questioned doing project #2 and going straight to project #7, which would replace the current lift station all together, as more cost effective.

### **NEW BUSINESS:**

The mainline extension agreement and re-issued will-serve letter for the Lockeford Vista Project was discussed. John Anderson and Evan Licht both spoke on behalf of the project. It was stated there has not been a complete resolution on the arsenic issue, but it is key getting clearance from the State. Andrew Ramos commented that this agreement is a continuation of the 2016 agreement with conditions pertaining to: arsenic remediation, annexation fee, and a timeline for construction of the project.

A motion was made by Ozzie Neal, seconded Jane Loney to approve the Amended and Restated Mainline Extension Agreement, and Re-Issued Will-Serve Letter for the Lockeford Vista project. Motion carried unanimously.
